## Subject: Ohio EPA Approval – Remedial Investigation (RI) Report Former Satralloy Site, Jefferson County

Dear Ms. Nielsen:

Ohio Environmental Protection Agency (Ohio EPA) has completed its review of the *Remedial Investigation (RI) Report*<sup>1</sup> for the former Satralloy Site, located in Jefferson County, Ohio. The report was submitted to Ohio EPA by Cypress Amax Minerals Company (CAMC) on May 17, 2023.

As noted by Ohio EPA in previous correspondence and discussions, the Human Health Risk Assessment (HHRA) included as Appendix A of the *RI Report* calculated the risk levels from slag exposure using the outdoor worker scenario. On that basis, the HHRA concluded that only the Lowland Slag-South area exceeded a 1x10<sup>-5</sup> risk level. After discussion, CAMC agreed that using the composite worker is an appropriate scenario for calculation of risk, and on that basis RI Figure 7.1.1 illustrates that all areas of slag exceed a 1x10<sup>-5</sup> risk level. These areas form the basis for the on-site consolidate-and-cover remedy described in *Interim Action Workplan Amendment 10*<sup>2</sup>, which was approved by Ohio EPA on February 29, 2024. Interim Action Workplan Amendment 10 uses a hexavalent chromium concentration of 63 mg/Kg (calculated using the composite worker) as the soil cleanup goal for the site.
